Staff Summary: By law, the Board of Supervisors must set the tax rate of the County Cooperative Extension annually in an amount between 1 cent and 5 cents per \$100 of assessed valuation ad valorem tax rate to provide annual funding. The 1.28 cents per \$100 assessed valuation ad valorem tax rate requested is the same levy from prior years.
