Discussion and possible action to recommend to the Board of Supervisors the approval 6. of the expenditure of \$2,500 from the FY 2011-12 Revolving Fund for the Redevelopment Agency to support Sierra Nevada Ballet 2011 Peanutcracker, as an expense incidental to the carrying out of the redevelopment plan.

Staff Summary: This is a request to expend \$2,500 from the Revolving Fund from the Redevelopment Agency to subsidize the rent of the Bob Boldrick Theater in the Community Center, NRS 279.628 permits the expenditure of money from the redevelopment revolving fund for the purpose of any expenses necessary or incidental to the carrying out of the redevelopment plan adopted by the Carson City Board of Supervisors. Prior to approving the expenditure, the Board of Supervisors must make the findings that there is a causal connection between this redevelopment effort and the need for the expenses, the expenses are needed to ensure the success of the redevelopment plan and that the amount of the expenses to be given are minor in comparison to the money required for the overall redevelopment plan.

Discussion and possible action to recommend to the Board of Supervisors the approval 7. of the expenditure of \$2,500 from the FY 2011-12 Revolving Fund for the Redevelopment Agency to support Pinkerton Ballet Annual Nutcracker, as expenses incidental to the carrying out of the redevelopment plan.

Staff Summary: This is a request to expend \$2,500 from the Revolving Fund from the Redevelopment Agency to subsidize the rent of the Bob Boldrick Theater in the Community Center for the Pinkerton Ballet Theatre's Annual Nutcracker Ballet, a unique special event scheduled for this coming Thanksgiving Day weekend. NRS 279.628 permits the expenditure of money from the redevelopment revolving fund for the purpose of any expenses necessary or incidental to the carrying out of the redevelopment plan adopted by the Carson City Board of Supervisors. Prior to approving the expenditure, the Board of Supervisors must make the findings that there is a causal connection between this redevelopment effort and the need for the expenses, the expenses are needed to ensure the success of the redevelopment plan and that the amount of the expenses to be given are minor in comparison to the money required for the overall redevelopment plan. The action requested of the Redevelopment Authority is to recommend to the Board of Supervisors the approval of this expenditure.

8. Discussion and possible action to recommend to the Board of Supervisors the approval of the expenditure of \$5,000 from the FY 2011-12 Revolving Fund for the Redevelopment Agency to support the Capital City Arts Initiative, as an expense incidental to the carrying out of the redevelopment plan.

Staff Summary: This is a request to expend \$5,000 from the Revolving Fund for the Redevelopment Agency to support annual programming of the Capital City Arts Initiative (CCAI). CCAI's activities include contemporary art exhibitions and arts education programs for the area's diverse adult and youth populations. NRS 279.628 permits the expenditure of money from the redevelopment revolving fund for the purpose of any expenses necessary or incidental to the carrying out of the redevelopment plan adopted by the Carson City Board of Supervisors. The action requested of the RACC is to recommend to the Board of Supervisors the approval of this expenditure.

9. Discussion and possible action to recommend to the Board of Supervisors the approval of the expenditure of \$15,000 from the FY 2011-12 Revolving Fund for the Redevelopment Agency to support the CCCV&B, the Annual Ghost Walks and Cemetery Tour, as an expense incidental to the carrying out of the redevelopment plan.

Staff Summary: This is a request to expend \$15,000 from the Revolving Fund for the Redevelopment Agency to support this year's annual Ghost Walks and the new event Cemetery Tour. NRS 279.628 permits the expenditure of money from the redevelopment revolving fund for the purpose of any expenses necessary or incidental to the carrying out of the redevelopment plan adopted by the Carson City Board of Supervisors. The action requested of the RACC is to recommend to the Board of Supervisors the approval of this expenditure.

10. Discussion and possible action to recommend to the Board of Supervisors the approval of the expenditure of \$7,500 from the FY 2011-12 Revolving Fund for the Redevelopment Agency to support Firkin & Fox Pub, the 2011 Concerts; Firkin Fridays, Legends of the West, Dancing for Cancer, Rocking the Square, as an expense incidental to the carrying out of the redevelopment plan.

Staff Summary: This is a request to expend \$7,500 from the Revolving Fund for the Redevelopment Agency to support Firkin & Fox Pub, the 2011 Concerts; Firkin Fridays, Legends of the West, Dancing for Cancer, Rocking the Square. NRS 279.628 permits the expenditure of money from the redevelopment revolving fund for the purpose of any expenses necessary or incidental to the carrying out of the redevelopment plan adopted by the Carson City Board of Supervisors. The purpose of the Plan is to "encourage and assist in providing

'people oriented areas' in the Downtown for daytime and evening special events and promotional activities," and "establish the highest level of recreational opportunity for residents and visitors of all age levels." Summer Concerts 2011; music for all ages, attracts thousands to our Downtown during times that are otherwise quiet and inactive. The increased foot traffic generated by the Downtown Streets within this "people oriented area" has a direct impact on the success of many small businesses and cultural facilities throughout the area. Thus, there is a casual connection between this redevelopment effort and the need for the expenses. Finally, this funding is incidental to overall cost of implementing the redevelopment plan. The action requested of the RACC is to recommend to the Board of Supervisors the approval of this expenditure.

11. Discussion and possible action to recommend to the Board of Supervisors the approval of the expenditure of \$2,000 from the FY 2011-12 Revolving Fund for the Redevelopment Agency to support Mom & Pop's Diner, Friday's at the Cove, as an expense incidental to the carrying out of the redevelopment plan.

Staff Summary: This is a request to expend \$2,000 from the Revolving Fund for the Redevelopment Agency to support Mom & Pop's Diner, Friday's at the Cove. NRS 279.628 permits the expenditure of money from the redevelopment revolving fund for the purpose of any expenses necessary or incidental to the carrying out of the redevelopment plan adopted by the Carson City Board of Supervisors. The action requested of the RACC is to recommend to the Board of Supervisors the approval of this expenditure.
