Staff Summary: The Redevelopment Area No. 2 Plan was adopted in 2004. The primary purpose of the current Plan is to retain and enhance auto sales on South Carson Street. One of the Board of Supervisors' initiatives is to review the objectives of the Area No. 2 Plan for possible amendments to include other objectives and activities. After notification of all property owners within Redevelopment Area No. 2, the RACC took public comments and recommended suggested changes to staff on August 6, 2012, and those changes have been incorporated into the amended Plan.

5-2 For Possible Action: To make recommendations to the Redevelopment Authority regarding the expenditure of approximately \$72,000 of Redevelopment funds budgeted in the current fiscal year (FY 2012/13) for "Undesignated Infrastructure Projects."

Staff Summary: Approximately \$72,000 of the Redevelopment budget is available for infrastructure projects for the current fiscal year, from July 2012 through June 2013. The funding may be used on projects within the Redevelopment District, Project Areas 1 (Downtown) or 2 (S.

Carson Street). The available funds have not been allocated to any specific project, nor have specific infrastructure project been identified for the Redevelopment District. The RACC may make recommendations regarding how to use the available funds and the types of infrastructure projects on which it should be used. RACC voted to continue this item to a future at its meeting on August 6, 2012.
