


Survey Highlights

- Over 72% reported being very or somewhat concerned with cracks or potholes in the roadway
- Over 64% reported being very or somewhat concerned with sidewalks in poor condition
- Over 76% reported being very or somewhat concerned with driver behavior
- Of the seven options for spending money (Question 9) "repair exiting roads" got the most allocation 34%
- Most respondents provided an e-mail address indicating they would like to receive additional information about the transportation plan






Question 3: What is your age?




Question 4: In what ZIP code is your workplace located?




Question 5: How far is your commute to work/school?


