**D-1 ADM-17-060** For Possible Action: To consider an Administrative Permit application from Liberty Homes, LLC (Property Owner, Annette & David Yonemoto) to allow an accessory structure to exceed 50% but not more than 75% of the size of the primary structure, and more than 5% of the parcel size on property zoned Mobile Home 12000 (MH12), located at 2240 Sneddon Way, APN 008-174-08. (Kathe Green)

Summary: The applicant is requesting to construct a 780 square foot detached garage on the subject property. This building would be in addition to another detached accessory structure on the site. The cumulative square footage of accessory buildings would be 1,260 square feet, or 61.3% of the size of the primary structure and 5.82% of the size of the parcel. An Administrative Permit is required for the square footage of the accessory structures to exceed 50% but not more than 75% of the size of the main structure and more than 5% of the parcel size in detached accessory structures.
