Carson City Investment Pool for this expense. In addition we prepaid dental premiums for our new insurance carrier Standard, which was \$8,417.42. The prepaid premiums will correct themselves when we receive the PERS deduction and the Carson City Subsidy for July. We use the Carson City Investment Pool for all operations, in order to make the collection and payment of money work seamlessly with the current City processes. We invest as much money as possible; we keep a minimal amount of money in the Carson City Investment Pool. Given the unexpected prepayment of premiums cash as of June 30, 2016 is negative by \$4,216.46. At this time, I'd like to transfer \$10,000 to the Carson City Investment Pool from the OPEB Checking account to bring it back to a positive balance.

Ms. Russell advised of one "corrected misstatement of \$9,584; basically, reclassifying revenue between employer and employee [contributions]. ... the other communication was an internal control letter and they did have one material weakness and that was the retiree subsidy used to be offered as part of all the current contracts. It was never written in the contracts, but it was \$6 per year of service up to 30 years, but you had to have more than ten years of service. Because it wasn't written down anywhere, they considered that a control deficiency. So it is now in the HR Policies and Procedures so, hopefully, next year we won't have this finding." Ms. Russell responded to questions of clarification, and discussion followed.
