Staff Summary: The RACC bylaws require the election of a Chair and Vice-Chair at the first RACC meeting of the calendar year. The formerly elected Chair resigned from the RACC, leaving a vacancy for the remainder of 2017. New elections for Chair and Vice-Chair will occur at RACC's first meeting in 2018.

4.B For Discussion Only: To provide a presentation regarding the 60% design of the Downtown Curry Streetscape Project and to improve the five cross streets between Carson Street and Curry Street from Musser to Robinson. (Dan Stucky; DStucky@carson.org)

Staff Summary: The Board of Supervisors approved the 60% design of the Downtown Curry Streetscape Project on October 19, 2017, and authorized funding for the project. The approval allows for the project to incorporate similar type and quality of streetscape improvements that were recently constructed along Carson Street for the Downtown Carson Streetscape Project. In addition to the streetscape improvements on Curry Street, staff plans to initiate the design of street beautification improvements for five east-west downtown streets between Carson Street and Curry Street (Robinson Street, Spear Street, Telegraph Street, Proctor Street and Musser Street) and the Telegraph to Spear alley. The improvements to the cross streets and alley are funded by \$550,000 from the Redevelopment Revolving Fund. The proposed schedule is to incorporate all the above improvements into the Downtown Curry Streetscape Project and construct during the 2018 construction season.

4.C For Possible Action: To approve Redevelopment Christmas ornament themes for 2018-2020.

Staff Summary: Since 2003, the Carson City Redevelopment agency has annually created Christmas ornaments based on historic buildings in the City. These ornaments are sold for to local retailers, which then resell the ornaments to the public. Supervisor Lori Bagwell has taken on the task of coordinating ornament production over the last few years and is requesting guidance and approval from the Redevelopment Authority Citizens Committee on the ornament themes. The proposed themes for the following three years (2018-2020), respectively, are: The Wungnema House, the Western Nevada College Observatory, and the Stewart Indian School.

4.D For Possible Action: To make a recommendation to the Redevelopment Authority regarding the expenditure of \$100,000 from the FY 2018 Redevelopment Revolving Fund for the Downtown Curry Streetscape Project, for a total of \$350,000 from the FY 2018 Redevelopment Revolving Fund for the Project; and to provide direction to staff regarding the Redevelopment Revolving Fund allocation plan for unallocated funds for Fiscal Year (FY) 2019. This may include identifying new projects and/or programs to fund for the current or future years, depending on the availability of funds. The RACC will make final recommendations to the Redevelopment Authority regarding the FY 2019 Redevelopment Allocation Plan at its regular meeting on February 5, 2018. The proposed action will also authorize the allocation of \$100,000 from FY 2017 budget savings into the Downtown Curry Streetscape Project to allow for the project completion in 2018.

(5:34:30) – Vice Chair Hannaman entertained public comments; however, none were forthcoming. She also announced the resignation of Chairperson Wickstead due to an employment-related move, effective immediately. Vice Chair Hannaman believed that a new chair would be elected in the November RACC meeting.

4. **MEETING ITEMS**

FOR POSSIBLE ACTION: TO APPROVE THE EXPENDITURE OF UP TO \$25,000 FOR FAÇADE IMPROVEMENTS TO THE BUILDING LOCATED AT 410 N. CARSON STREET, WITHIN REDEVELOPMENT AREA NO. 1, AND TO GRANT A WAIVER OF THE POLICY REQUIRING A MINIMUM OF THREE BIDS FOR THE PROPOSED IMPROVEMENTS.

(5:36:22) – Vice Chairperson Hannaman introduced the item and referenced the Staff Report incorporated into the record. She also invited applicant Dan Douglas to the podium to respond to members' questions. Mr. Douglas gave background on the property and referenced several photographs incorporated into the record. He reviewed the signage details and explained that if the sign did not look acceptable, he would have the item reagendized for approval of a new sign. Mr. Douglas also clarified that the project bid was much higher; therefore, he was requesting the maximum allowable funds for façade improvement.

(5:43:39) – Member Justice inquired why the sign cost was broken down separately and Mr. Douglas believed that it was the Staff's recommendation, since the awning cost was reimbursable but the cost of the sign was not. Member Barrette inquired about the apartments above the businesses in the building and he was informed that there would be two and at 1,100 square feet each, consisting of two bedrooms per apartment. Member Mullet believed that the building number looked out of proportion and Mr. Douglas noted that they could make the appropriate changes. Vice Chair Hannaman clarified that for the latter, permit department approval would suffice. Mr. Douglas also noted that he was at the "plan check" stage at the moment and addressed the issue of not having three bids. He stated that all contractors have been busy and that he wished to have the work done by a first-tier contractor. Vice Chairperson Hannaman referenced a Board of Supervisors resolution, attached to the Staff Report, which allowed the RACC to waive the three-bid requirement in certain conditions. Member Mullet noted that the bid was closer to \$60,000 and that the RACC was only reimbursing \$25,000, and believed it was a non-issue. There were no public comments and the Vice Chair entertained a motion.

(5:52:47) – MOTION: I move to approve the expenditure of up to \$25,000 for façade improvements to the building located at 410 N. Carson Street, within Redevelopment Area Number One, subject to the conditions of approval in the Staff Memo; and to grant a waiver of the policy requiring three bids for the proposed improvements.

PAVING

The same paving materials as used on Carson Street should be used in areas where the existing paving is deteriorating. Some sidewalks that already have paving in good condition could remain to create and eclectic feel to the streetscape, some existing pavers are different colors.



CROSS WALKS

Concrete banded paver crosswalks as used on Carson Street should be added to enhance the streetscape, slow vehicles and increase pedestrian safety.



PLANTER WALLS AND SEATWALLS

The addition of permanent planters, seatwalls and landscaping can be used in areas where there is room and in places where existing planters are already located.



EMBLEMS AND ICONS

The simple and cost effective addition of emblems in the paving and plaques on furnishings is proposed.







FURNISHINGS: BIKE RACKS, BENCHES, LIGHTING, TRASH RECEPTACLES, WAYFINDING, PLANTER POTS

The same furnishings as selected for Carson Street shall be used here. There is limited space for furnishings but the continuity will held create a downtown district. Existing planters and trash receptacles should be removed and replaced. Benches and bike racks should be added while additional wayfinding signs should be considered.

This 1,000 square-foot house was built just on the outskirts of Carson City in 1948.

Burton Wungnema, with the help of this father, Earnest Wungnema, and then pregnant wife, Pearl, used the stone from his father's fourteen quarries in Brunswick Canyon to build this home for his family. Pearl raised eight children in the home.

The house was built during the war and they couldn't get lumber, nails, or glass because of the shortage. That is why only half the upstairs was built. The windows, now removed, were from the Catholic churches in Brockway, Lake Tahoe, and Truckee, California. Earnest and Burton, while building the churches, purchased the windows because they were not made with frosted glass and the church was going to return them.

The fireplace was made from stone in Arizona. The face is cut stone of clouds and lightning and is the emblem of the Water clan of the Hopi Nation. The hearth is wonder stone. The boards on the ceiling were milled using the same dies used to build the original ceiling. Wungnema is a Hopi name for grow, as in growing corn.

Burton and Pearl came from Arizona as teens, met in Carson City, and married in 1947. They are both Hopi Indians. Pearl is in the Sun clan and Burton the Water clan. Burton passed away in 1956 and Pearl continues to live in Carson City.

This home is representative of the wonderful mason work done in the churches and homes built by Burton and 20 his father around Lake Tahoe from 1925 to 1955.

The Wungnema House is administered by the Foundation for the Betterment of Parks and Recreation and is available for small group meetings and events.

Stewart Indian School History

The Stewart Indian School is listed on the National Registrar of Historic Places







For ninety years, Stewart Indian School fulfilled a federal commitment to pursue Native American education in Nevada. Located three miles southeast of Carson City, the school grounds encompassed 240 acres. The school opened on December 17, 1890 with 37 students from local Washoe, Paiute and Shoshone tribes and three teachers.

In 1888, the Nevada Legislature passed a bill that authorized the sale of bonds to purchase land for an Indian boarding school. Once purchased, the land was conveyed to the Bureau of Indian Affairs who established the boarding school to train and educate Indian children with the ultimate goal of assimilation. The campus opened with a capacity for 100 students and included a Victorian-style wood framed dormitory and school house. As enrollment increased, new buildings included shops for training, a hospital, and a recreation room. A Virginia and Truckee Railroad stop was established by 1906 to deliver supplies and facilitate transporting students to and from the school. By 1919, 400 students attended the school. During the next 16 years, students learning stone masonry from their teachers, including Hopi stone masons, constructed over 60 native stone buildings.

Student curriculum included classes in reading, writing, and arithmetic but focused on vocational training in various trades, agriculture, and the service industry. Classes offered for boys included ranching and farming, mechanics, woodworking, painting, and carpentry, while girls attended classes in baking, cooking, sewing, laundry, and practical nursing. Much of the school's basic needs were supplied by students' products or fulfilled by their newly acquired skills. Vocational training remained the school's principal focus until a shift to academics occurred in the late 1960's. The school closed in 1980 due to federal budget cuts and earthquake safety issues with the masonry buildings.

The State of Nevada acquired the campus through several transactions during the 1990's and is now used by the State for classes, training, and agency offices, including the Nevada Indian Commission located in the former Superintendent's home. The Washoe Tribe of Nevada and California established the Stewart Community on much of the former school's land where they also occupy some of the buildings.

Today, the Stewart Indian School is listed on the National Registrar of Historic Places and the Stewart Indian Cultural Center is to be established in the former Administration Building. Memorabilia from the former Stewart Indian School is currently displayed at the Nevada State Museum's Under One Sky exhibit.

RECOMMENDED MOTION: I move to recommend to the Redevelopment Authority approval of the expenditure of \$100,000 from the FY 2018 Redevelopment Revolving Fund for the Downtown Curry Streetscape Project, for a total of \$350,000 from the FY 2018 Redevelopment Revolving Fund for the Project, as an expense incidental to the carrying out of the Redevelopment Plan that has been adopted by the Carson City Board of Supervisors, and based upon the findings that there is a causal connection between this redevelopment effort and the need for the expenses, the expenses are needed to ensure the success of the redevelopment plan and that the amount of the expenses to be given are minor in comparison to the money required for the overall redevelopment plan.

[Additionally, the RACC should have discussion and may identify potential projects or programs for funding in future budget years, based on available funding. Any projects or programs identified will be included for the RACC's consideration and recommendations to the Redevelopment Authority during the RACC meeting on February 5, 2018.]

DISCUSSION:

The Redevelopment Authority Citizens Committee (RACC) annually makes recommendations to the Redevelopment Authority. The Redevelopment Authority approved the attached Redevelopment Allocation Plan on March 16, 2017.

The purpose of this item is to:

- 1. Make a recommendation regarding the augmentation of the FY 2018 Redevelopment budget for the Downtown Curry Streetscape Project; and
- 2. Identify potential projects and programs for funding in the FY 2019 budget and subsequent years.

On June 1, 2017, the Board of Supervisors adopted Resolution 2017-R-19 authorizing the expenditure of \$250,000 in FY 2018 for the Downtown Curry Streetscape Project (side streets).

Allocations of \$200,000 and \$100,000, respectively, were allocated to the Project for the subsequent two years, for a total of \$550,000 from Redevelopment.

On October 19, 2017, the Board of Supervisors approved funding to complete the Downtown Curry Streetscape Project, including all the side streets, as one project in 2018 rather than spreading the completion of the side streets out over two to three years. To accomplish this, an additional \$100,000 in Redevelopment budget savings is proposed to be allocated to the project in FY 2018 (the proposed RACC action), and an additional \$100,000 is proposed to be allocated from the other Downtown Side Street Improvement fund in FY 2019 so the project can be completed and paid for by the end of summer/fall 2018 (FY 2019). The Downtown Side Street Improvement Fund will be augmented by an additional \$100,000 in FY 2020 to compensate for the reduction in funding in FY 2019. (See modifications in highlighted cells in the attached Redevelopment Allocation Plan.)

Staff will also take comments and direction from RACC regarding other projects and programs within the five-year Redevelopment Allocation Plan and prepare information for the RACC meeting on February 6, 2017, at which time the RACC will make formal recommendations regarding priorities and funding for the allocation plan to implement the priority Redevelopment activities.

After including costs savings and additional revenues from FY 2017 (and adjusting downtown streetscape funding as noted above), there is approximately \$98,788 of undesignated funds available in FY 2018 for allocation in this Fiscal Year or to roll forward to future years' projects and programs. The five-year Redevelopment Allocation Plan with updated projections is attached.

FY 2017 Status Report

Following is a status report on the activities in the attached Redevelopment Revolving Fund Allocation Plan that were approved for last year (FY 2017).

Special Event equipment/infrastructure: \$20,000.

The approved outdoor projector and associated equipment were purchased (\$9,949) and are available for use through the Carson City Library, who is managing the rental of the equipment. The remaining \$10,000 was allocated towards the purchase of tables and chairs for the Community Center events, and the purchase of these items is still pending.

Special Event street closures: \$25,000.

Public Works provides the street closure services for all downtown special events. The funds have been used to offset that cost.

Façade Improvement Program: \$200,000.

The attached spreadsheet shows the current status of projects funded last year as well as the project funded this year. There are two projects still under construction from last year and pending reimbursement, and one project under construction under this years' funding. The unused portion of the FY 2017 funds has been rolled forward into the FY 2018 Undesignated account for reallocation to other projects or programs.

Reimagine Space Art Program: \$10,000.

Funding for the Reimagine Space art program was allocated to the Carson City Culture and Tourism Authority (formerly the Visitors Bureau) late during last year. Those funds have been

rolled forward to this year. The Culture and Tourism Authority has indicated that they plan to implement the project and use the funds within the current Fiscal Year.

Historic Blue Line Rehabilitation: \$26,000.

This project has been delayed, at the direction of the Board of Supervisors, to evaluate long-term solutions for identifying the historic Blue Line tour. A committee has been formed that includes the Transportation Division and the Visitors Bureau. The long-term solution is planned to involve the replacement of the painted blue line with permanent markers in the sidewalks. The Redevelopment funds will be use for this with the additional funds coming through the Visitors Bureau.

FY 2018 Status Report

Following is a status report on the activities in the attached Redevelopment Revolving Fund Allocation Plan that were approved for this year (FY 2018).

Downtown Project East/West side streets and alley: \$350,000 (+ \$200K FY19).

The Downtown Curry Streetscape Project is scheduled to start in 2018 and will include the side streets and Telegraph alley with the approved Redevelopment funding.

Special Event equipment/infrastructure: \$5,000.

The annual funding of \$5,000 is planned to address special event needs as they arise. There is no anticipated use for these funds at this time.

Façade Improvement Program: \$100,000.

A total of \$25,000 has been allocated for one project this year, leaving \$75,000 available. See the attached spreadsheet for more detail.

Special Event funding: \$30,000.

A total of \$19,500 of the available \$30,000 has been allocated to Special Events, leaving \$20,500 available in the current Fiscal Year for events that may request assistance. A total of \$25,000 was allocated to the Arts and Cultural Commission for allocation to events, as well.

Utility Assistance Program: \$20,000.

This activity would include participation in the cost of extending or relocating off-site utilities for new development or redevelopment of a property. There are no known projects currently that would utilize such a program, but requests have been made in the past for such assistance and the money has been reserved for the activity. A utilities assistance program could help offset the cost of development where existing conditions with utilities are not conducive to developing a property. Policies and procedures need to be developed to implement such a program, but the existing Redevelopment Authority Policies and Procedures provide a good framework in which to review and approve any applications that may come in.

Downtown Entry Signs: \$30,000.

The RACC recommended the allocation of funds for downtown entry signs. With Public Works currently focused on the Downtown Curry Street project and South Carson Street project, it is likely that this project will be delayed until those projects are completed. It may be particularly appropriate to wait until the design of the portion of Carson Street south of Fifth Street is underway to help identify an appropriate location and design of the entryway signage.

Part-time Code Compliance Officer.

While this is no longer a line item on the Allocation Plan, the RACC and Redevelopment Authority authorized the allocation of funds last year to pay for a part-time Code Compliance Officer to improve code enforcement within the Redevelopment District. A part-time officer has been hired, and Redevelopment funds have been shifted to the Administrative Account to pay for the additional staff. The part-time officer is focusing primarily on parking enforcement and other downtown code compliance issue. This staffing addition also helps free up the two other compliance officers to deal with code compliance issues within the Redevelopment District.

Conclusion:

The RACC should have discussion and provide direction to staff regarding projects and programs that the Redevelopment Authority might want to consider for the remainder of FY 2018 and for the FY 2019 or future budgets. Redevelopment staff will return to RACC on February 5, 2018, with any necessary additional information for RACC to make formal recommendations to the Redevelopment Authority. The RACC and Redevelopment Authority will review the expenditure plan each year and may revise annual budgets and projected expenses based on updated priorities.
