Background/Issues & Analysis

NDOT has announced their call for projects for the Federal Fiscal Year (FFY) 2019-2020 funding cycle Applications can be submitted as an infrastructure or non-infrastructure project. Eligible infrastructure projects include: construction of pedestrian and bicycle facilities, historic preservation, vegetation management, and environmental mitigation. Eligible non-infrastructure projects include: Safe-Routes to School (SRTS) related projects and programming.


The City's infrastructure grant application is requesting \$1.6 million with 5% local match for a multi-use path from Colorado Street to the Edmonds Sports Complex. This project builds off of the 2011 Carson City Freeway Corridor Multi-Use Path Alignment Alternatives Study which aims at creating a regional network.

The City's non-infrastructure grant application is requesting \$700,000 with 5% local match for a Western Nevada Safe Routes to School Coordinator and associated activities for FFYs 2020-2023. Currently, the Western Nevada Safe Routes to School program is funded through June 30, 2020 using TAP funds. This application is to continue the program and allow for program expansion.

Proposed Motion

Move to allocate Federal Fiscal Year (FFY) 2018 Surface Transportation Block Grant (STBG) funds to Fairview Drive between S. Carson Street and Roop Street.

Background/Issues & Analysis

In July 2017, the Carson City RTC allocated \$372,372 to the South Carson Street Complete Streets project. CAMPO's December 2017 action allocated \$650,628 to the Carson City RTC. Eligible projects include preservation and reconstruction improvements to transportation facilities located on the Federal-aid highway system. The Federal-aid highway system typically includes the major roadways within a region. Local roads are not eligible for STBG funds. STBG funds can only be used within the urban area delineated by NDOT's Functional Classification Maps. A functional classification map is provided for reference.

The proposed project on Fairview Drive includes a partial reconstruction and a partial mill and overlay between Carson Street and Roop Street. A map of the proposed project is attached for reference.
