### **ABSTRACT OF THE VOTE Primary Election - June 12, 2018**

I, Susan Merriwether, Carson City Clerk-Recorder, do hereby certify the enclosed to be a full, true, and correct Summary Report and Precinct Report of Carson City, Nevada polled at the June 12, 2018 Primary Election.

Of the 9,058 ballots cast in the 25 precincts:

1. Nine (9) voters have been accounted for as "Fleeing Voters".
  - a. Three (3) Early Voting.
  - b. Six (6) Election Day.
2. One (1) voter received and voted a second ballot in error on Election Day.

3. There were no Provisional Ballots issued.
4. There were no tabulation errors in the 25 precincts.

The foregoing discrepancies would not alter the outcome of any race in this Primary Election.



## STATEMENT OF EVENT

I, Susan Merriwether, Carson City Clerk-Recorder, was made aware of the following events which took place at the Carson City Courthouse polling location on June 12, 2018:

A voter was issued, and voted, two (2) ballots in the 2018 Primary Election held in Carson City, NV.

The voter first appeared to vote on June 6, 2018 during Early Voting. The same voter then appeared to vote on Election Day, June 12, 2018. During the voter check-in process on Election Day, it was noticed that a ballot had previously been issued. However, in the rush of checking the voter in, the election worker thought she had inadvertently issued a ballot on the electronic pollbook without completing the check-in process. The election worker notified staff members and requested further assistance. The additional staff members asked the voter if he had previously voted in the Primary Election and the voter stated he had not. A Supervisor Password was entered into the electronic pollbook which allowed for a ballot to be re-issued and handed to the voter.

The staff members reviewed the electronic pollbook data conveyed to Central Point (the secured central cloud that holds the electronic pollbook data during early voting and election day.) Central Point had the voter's signature captured on June 6, 2018. This proved the voter had previously voted.

The Chief Deputy Clerk was notified and the voter was located as he was exiting the polling location. He was asked again if he previously voted in this election. The voter stated he had voted in the *Primary Election* but that he thought he was now voting in the *General Election*.

I was notified by the Chief Deputy of the event and instructed my office to immediately contact the Carson City District Attorney. I notified the Nevada Secretary of State. My office was advised by the District Attorney to file a police report with the Carson City Sheriff's Office. This report was filed on Wednesday, June 13, 2018. The matter is currently pending investigation by the Sheriff's Office and the District Attorney's Office.

To address the above stated event, the electronic pollbooks will **not** allow for a ballot to be issued to the voter until the voter's signature is captured either electronically or on a paper roster. This error appears to be strictly administrative and not a cause of a technical malfunction of the electronic pollbook.
