**6.A** (For Possible Action) To direct staff to pursue the proposed transportation infrastructure projects for Performance District 1, as funding permits.

**Staff Summary:** Staff has identified five transportation infrastructure projects for Performance District 1. If approved, staff will move forward with the development and refinement of cost estimates and project design. The projects will extend the life of the roadways as well as improve the ride quality. The proposed projects were presented to the Transportation Resource Advisory Forum of Carson City (TRAFCC) on August 8th and received their support.

**6.B** (For Possible Action) To adopt a Resolution authorizing the filing of an application for a Federal Transit Administration Section 5310 grant under 49 U.S.C. Chapter 53, and to authorize the RTC Chair to sign the FTA Fiscal Year 2018 Certifications and Assurances section of the RTC application for 5310 funds.

**Staff Summary:** Staff has prepared an application for the fiscal year 2018 apportionment of Federal Transit Administration (FTA) Section 5310 funds, the disbursement of which is determined by the Carson Area Metropolitan Planning Organization (CAMPO). Any funds received from the 2018 5310 apportionment will be used to fund costs associated with operating the Jump Around Carson (JAC) transit system.

**6.C** (**For Possible Action**) To adopt a Resolution authorizing the filing of an application for a Federal Transit Administration Section 5339 grant under 49 U.S.C. Chapter 53, and to authorize the RTC Chair to sign the FTA Fiscal Year 2018 Certifications and Assurances section of the RTC application for 5339 funds.

**Staff Summary:** Staff has prepared an application for the fiscal year 2018 apportionment of Federal Transit Administration (FTA) Section 5339 funds, the disbursement of which is determined by the Carson Area Metropolitan Planning Organization. Any funds received from the 2018 5339 apportionment will be used to fund capital costs associated with updating the Jump Around Carson (JAC) vehicle fleet.

**6.D** (**For Possible Action**) To direct staff to allocate \$160,000 of Surface Transportation Block Grant (STBG) funds to a sewer and roadway improvement project on Airport Road, between Douglas Drive and Woodside Drive, for roadway reconstruction purposes.

**Staff Summary:** The City's 5-year Wastewater Capital Improvement Plan (CIP) includes a sewer infrastructure replacement on Airport Road from Douglas Drive to Woodside Drive due to the poor conditions of the sewer main and manholes, as well as to address existing flow capacity deficiencies. The project requires cutting into the existing road and patching the roadway after the utility work concludes, with an estimated patching cost of \$265,000. To leverage City funding and reduce expenditures on what would ultimately be a short-term roadway patching, staff is proposing to utilize STBG funds to finance reconstruction of the roadway concurrent with the utility upgrades project. This would create a new roadway surface over the entire roadway and not just a linear patch down the middle.
