E. Public Hearing Matters

E-1 For Possible Action: HRC-18-175 – To discuss and potentially provide input, as a consulting party pursuant to a Section 106 review, to determine if the South Carson Street Complete Streets Project will have an adverse effect on any property listed or eligible for listing on the National Register of Historic Places. The project involves improvements to South Carson Street from 5th Street to Appion Way. (Hope Sullivan, hsullivan@carson.org)

Staff Summary: The South Carson Complete Streets Project involves the portion of South Carson Street from 5th Street to the intersection of South Carson Street and Appion Way. The project includes pedestrian safety measures, ADA-compliant sidewalks and curb ramps, narrowed travel lanes, a buffered multi-use path, dedicated bicycle facilities, a roundabout, improvements to stormwater infrastructure, public art, lighting fixtures, new signals, upgrades to the water and sewer systems, and fiber optic communications improvements. As part of the Section 106 review, the HRC will determine if the proposed project will have an adverse impact on any properties eligible for listing or listed on the National Register of Historic Places, and identify alternatives that could avoid, minimize or mitigate these impacts.

E.2 For Possible Action: HRC-18-185 – To discuss and potentially provide input, as a consulting party pursuant to a Section 106 review, to determine if the replacement of a roof will have an adverse effect on any property listed or eligible for listing on the National Register of Historic

Places. The property is located at 501 West King Street, APN 003-206-01. (Hope Sullivan, hsullivan@carson.org)

Staff Summary: The applicant is seeking to re-roof an existing building utilizing composite shingle roofing. The shape of the roof will not be modified. As part of the Section 106 Review, the HRC will determine if the proposed project will have an adverse impact on any properties eligible for listing or listed on the National Register of Historic Places, and identify alternatives that could avoid, minimize or mitigate these impacts.

E.3 For Discussion Only – HRC-18-189 – Discussion regarding any follow up desired based on the joint meeting with the Redevelopment Agency Advisory Committee (RACC) conducted on December 3, 2018.

Staff Summary: On December 3, 2018, the Commission conducted a joint meeting with RACC and heard presentations on Jack's Bar rehabilitation, the Federal Tax Credit Program, the South Carson Street Plan, and the City's Façade Improvement Program. The purpose of this item is to give the Commission an opportunity to discuss the items reviewed at the December 3 meeting, and to determine if any follow up is desired. Any follow up identified will be placed on a future meeting agenda.
