commended Ms. Maloney's presentation, and thanked her. Ms. Maloney responded to additional questions of clarification. Chairperson Kimbrough commended and thanked Ms. Maloney for her presentation.

Chairperson Kimbrough entertained public comment. (4:59:59) NDOT Federal Programs Manager Louis Lem advised that the "current six-year federal money is authorized by Congress through 2020. So, again, it's important to keep that horizon in mind too."

6(B) POSSIBLE ACTION TO APPROVE THE SUBMITTAL OF A REQUEST TO THE NEVADA DEPARTMENT OF TRANSPORTATION TO RECLASSIFY COCHISE STREET, BETWEEN CLEARVIEW DRIVE AND BENNETT AVENUE, AS A MINOR COLLECTOR ROADWAY (5:00:46) - Chairperson Kimbrough introduced this item. Mr. Goering presented the agenda materials, and responded to questions of clarification. Member Bonkowski expressed the opinion "we don't currently have an adequate road structure in the southwest to meet or keep up with the traffic that will be generated by the projects that have gotten entitlements and are beginning to pull permits. So this is the first step for us to start building that infrastructure to meet the demand that's going to be coming." Mr. Goering responded to additional questions of clarification, and discussion followed.

Chairperson Kimbrough entertained public comment and, when none was forthcoming, a motion. Member Bagwell moved to approve the submittal of a request to the Nevada Department of Transportation to reclassify Cochise Street, between Clearview Drive and Bennett Avenue, as a minor collector roadway. Member Bonkowski seconded the motion. Chairperson Kimbrough entertained discussion on the motion and, when none was forthcoming, called for a vote. Motion carried 5-0.

Chairperson Kimbrough entertained additional questions or comments of the CAMPO members and, when none were forthcoming, advised that LSC Transportation Consultants, Inc. has an excellent reputation in the Tahoe Basin and other areas that they've worked. (5:40:01) LSC Transportation Consultants, Inc. Principal Gordon Shaw thanked Chairperson Kimbrough for his kind words. Mr. Shaw thanked staff "for the effort that went into getting us to this point." He provided background information on his relocation to the area in 1992, and past projects done for Carson City. He commended the process leading to development of the contract, and commented "there's a lot of expenditures that social service programs do in the whole CAMPO area for transportation. And this gives us a chance to look at the public transit as well as all those other little vans you see running around and trying to see where we can save some dollars and make better use of the dollars."

Chairperson Kimbrough entertained public comment and, when none was forthcoming, a motion. Member Bagwell moved to recommend approval of Contract No. 1819-128, JAC Transit Development and Coordinated Plan Services, to LSC Transportation Consultants, Inc., for a total not-to-exceed amount of \$86,470.00, to the Carson City Regional Transportation Commission. Background/Issues & Analysis

An initial ADA Transition Plan for Transportation Facilities was created in March 2015. The plan inventoried 26 signalized intersections, 15 sidewalk corridors, and 41 transit stop facility locations.

The updated plan will focus on a gradual progression towards a comprehensive inventory. The plan is being modeled after Carson City's recently approved Pavement Management Plan, which uses performance districts and a set of criteria (pavement maintenance schedule, safety needs, traffic volumes, construction efficiencies, roadway functional class, and funding opportunities) to prioritize infrastructure projects. Since ADA improvements are required with certain pavement preservation treatments, staff believes that coupling the ADA Transition Plan with the Pavement Management Plan will result in a greater number of ADA improvements completed over time.

Over the past year, CAMPO and Carson City staff has worked to create an inventory of curb ramp locations and sidewalk for all five performance districts along the City's regional roads. The inventory has been created with the use of aerial photography and ground work.

In fiscal year 2018, Carson City's Streets Maintenance division poured 415 yards of concrete, 15,239 square feet of sidewalk/flatwork, and five (5) wheel chair ramps. To document all Carson City investment in ADA improvements, City work orders are being modified to better track which work orders contribute to the removal of ADA barriers. Much of this work is completed on local roads, where an inventory has not yet been developed.
