Staff Summary: At its meeting of July 12, 2018, the Historic Resource Commission (HRC) approved a request for a partial demolition, an addition, a re-roof, modifications to the chimneys, a new porch, new windows, and a new fence on property. The HRC will view progress on that work while on site.

Additionally, the HRC will look at a structure proposed for demolition, and the locations of a new garage, a new office/kitchen structure, and an aluminum lattice patio and walk cover. The HRC will not deliberate or take any action while on site.

HRC-19-019** Site visit to 507 North Division Street to view proposed areas work on the subject property including replacement of windows, repair and resurfacing of entries, repair and replacement of fencing, replacement of garage doors, and installation of pavers between the building and the sidewalk on property zoned Residential Office, APN 003-221-01.
