#### **PUBLIC HEARING**

**E.1 LU-2020-0051\*** For Possible Action: Discussion and possible action regarding a request to amend a Special Use Permit (LU-2020-0041) to allow for the installation of a backup generator for the Carson City School District Office, on property zoned Public (P), located at 1402 West King Street, APN 003-171-01. (Heather Ferris, <a href="mailto:hferris@carson.org">hferris@carson.org</a>)

Summary: On November 17, 2020 the Planning Commission approved a 975 square foot addition and remodel to the existing District Office. Since this approval, the applicant has determined the addition of a backup generator will be beneficial to provide power to the District Office for 24 hours in the event of a power outage. The generator is proposed to be located north of the District Office in the existing equipment yard. The generator will be screened by the existing slatted chain-link fence and will be installed within a sound attenuated weather protective enclosure. Per CCMC 18.04.170, the use may only be established or modified subject to a Special Use Permit. Since the generator was not contemplated as part of LU-2020-0041, an amendment to the Special Use Permit is required. The Planning Commission is authorized to approve an amendment to a Special Use Permit.

#### **PUBLIC HEARING**

**E.2 LU-2020-0044\*** For Possible Action: Discussion and possible action regarding a request for Special Use Permit to allow for an automobile paint and body repair shop on property zoned General Commercial (GC) located at 2234 S. Carson Street, APN 009-052-09. (Heather Ferris, hferris@carson.org)

Summary: The applicant is seeking to utilize a 3,000 square foot space in an existing building for an automobile paint and body repair shop and approximately 9,000 square feet of space for outdoor storage associated with the repair shop. The applicant currently operates an auto repair shop at this location, which is an allowed use in the GC zoning; however, painting and body work require a Special Use Permit. The Planning Commission is authorized to approve a Special Use Permit.

**E.3 ZA-2020-0001** For Possible Action: Discussion and possible action regarding possible amendments to the Carson City Municipal Code, Title 18 Appendix (Development Standards), Division 4 (Signs). (Lee Plemel, lplemel@carson.org)

Summary: The Planning Commission is conducting public workshops and making recommendations regarding possible updates to Title 18 (Zoning) of the Carson City Municipal Code. The Commission will be reviewing the code section as identified in the agenda title and may make recommendations to staff for possible amendments. The Commission will make final recommendations regarding these chapters to the Board of Supervisors at a future meeting.

This policy will remain effective during the period of time the State of Nevada is under a State of Emergency as declared by the Governor due to the COVID-19 pandemic and is intended to achieve the efficient conduct of meetings while facilitating public participation via telephonic means. No action may be taken on a matter raised under public comment unless the item has been specifically included on the agenda as an item upon which action may be taken. The Chairman also retains discretion to only provide for the Open Meeting Law's minimum public comment and not call for or allow additional individual-item public comment at the time of the body's consideration of the item when: 1) it is deemed necessary by the chair to the orderly conduct of the meeting; 2) it involves an off-site non-action facility tour agenda item; or 3) it involves any person's or entity's due process appeal or hearing rights provided by statute or the Carson City Municipal Code.
