<u>Summary</u>: Carson City has used MCP for several CAD projects. MCP has provided a proposal to assist the City in procuring a suitable RMS/CAD system to replace Tiburon, with services including product selection, procurement, cutover, and interoperability to bring a new RMS/CAD online. Although MCP has agreed to nine milestones in its proposal, some services may not be needed depending on decisions and findings made in the course of the consultation process. Additionally, MCP travel may be reduced or eliminated based on the selection process. The amount for services is not to exceed \$171,220.
