9. City Manager

9.a. For Possible Action: Discussion and possible action regarding the appointment of one member to the Library Board of Trustees to fill a four-year term that will expire in June 2027. (Nancy Paulson, npaulson@carson.org)

Staff Summary: The Board of Supervisors appoints five persons who are residents of Carson City to serve as library trustees. Library trustees may serve up to two consecutive four-year terms. Julie Balderson-Knight's first term expired in June 2023, and she has applied for reappointment.

9.b. For Possible Action: Discussion and possible action regarding a First Judicial District Court Order in the matter of Carson Valley Meats, Inc. v. Carson City and Carson City Board of Supervisors, Case No. 22 OC 00036 1B, which (1) reverses the February 3, 2022, decision of the Board of Supervisors ("Board") to grant administrative appeals challenging the approval by the Planning Commission of a Special Use Permit ("SUP") for a commercial meat processing facility; and (2) issues the SUP as set forth in the Planning Commission's Notice of Decision, dated December 17, 2021, SUP File No. LU-2021-0308. (Nancy Paulson, npaulson@carson.org)

Staff Summary: On December 15, 2021, the Planning Commission approved Carson Valley Meat's SUP application for a commercial meat processing facility. That approval was administratively appealed to the Board on February 3, 2022, and the appeals were granted, reversing the approval of the SUP. Carson Valley Meats petitioned the First Judicial District Court for judicial review of the Board's

decision. On June 16, 2023, the Court issued an Order in favor of Carson Valley Meats.

10. Community Development - Planning

10.a. For Possible Action: Discussion and possible action regarding an application, SUB-2023-0215, from TLC at Blackstone Ranch, LLC ("Applicant") for a two-year extension of time for the approved tentative subdivision map known as Blackstone Ranch South (TSM-19-054) on property within the Blackstone Ranch South Specific Plan Area and zoned Single Family 6,000 ("SF6-SPA"), located approximately 140 feet to the east of the intersection of Trolley Way and Railroad Drive, Assessor's Parcel Number ("APN") 010-051-44. (Heather Manzo, hmanzo@carson.org)

Staff Summary: The Board of Supervisors ("Board") approved the tentative subdivision map on July 18, 2019. The developer has requested an extension of time stating that additional time will be necessary to satisfy Condition No. 43 which requires the relocation of an access easement to provide project access from the project site to East 5th Street that will require the cooperation of multiple government agencies. The Applicant is seeking Board approval for a two-year extension of time for the tentative subdivision map to allow this coordination to occur so the Applicant can secure easements that are necessary for access for the project.

11. Finance

11.a. For Possible Action: Discussion and possible action regarding a proposed resolution to levy the Carson City Fiscal Year ("FY") 2023-2024 ad valorem tax rates as certified by the Nevada Tax Commission. (Sheri Russell-Benabou, srussell@carson.org)

Staff Summary: By law, the Board of Supervisors sets the Carson City tax rates annually after the Nevada Tax Commission certifies the tax rates. The proposed resolution sets the tax rates as approved during the Board of Supervisors and Redevelopment Authority budget hearings and also sets the local rates for other governing bodies per the attached schedule. 11.b. For Possible Action: Discussion and possible action regarding the report on the condition of each fund in the treasury and the statements of receipts and expenditures through June 23, 2023, per NRS 251.030 and NRS 354.290. (Sheri Russell-Benabou, srussell@carson.org)

Staff Summary: NRS 251.030 requires the Chief Financial Officer (for the purpose of the statute acting as the County Auditor) to report to the Board of Supervisors,

at each regular meeting thereof, the condition of each fund in the treasury. NRS 354.290 requires the County Auditor to report to the Board of Supervisors a statement of revenues and expenditures based on the accounts and funds as were used in the budget. A more detailed accounting is available on the City's website – www.carson.org.

12. Public Works

12.a. For Possible Action: Discussion and possible action regarding a proposed resolution (1) conveying 1.133 acres of Carson City ("City") land known as 2621 Northgate Lane, APN 002-062-05 ("Property"), including the 15,841 square foot office building on the Property, to Adams Northgate, Inc. ("Adams") under NRS 244.284 for \$385,000; (2) authorizing the Mayor to execute and deliver a deed for the Property upon Adams' performance of the terms and conditions for conveyance; (3) terminating the four tenancies on the Property; and (4) terminating a maintenance agreement concerning the Property. (Randall Rice, RRice@carson.org Robert Nellis, RNellis@carson.org;).

Staff Summary: On April 21, 2022, the Board of Supervisors ("Board") adopted Resolution No. 2022-R-9 declaring intention to sell the Property under NRS 244.284 for no less than \$385,000 through an auction among qualified nonprofits. However, no bids were submitted, and the Board directed staff to dispose of the Property through a direct sale. The Hop and Mae Adams Foundation formed Adams Northgate, Inc., a Nevada non-profit corporation, to purchase the Property under NRS 244.284 and lease it to nonprofits providing charitable services in Carson City, at below market rates. Adams has offered such leases to all existing tenants, and terminating the existing leases is intended to facilitate those new agreements. The maintenance agreement to be terminated allows the City to use certain parking spaces along Northgate Lane in exchange for performing various landscaping maintenance activities.

12.b. For Possible Action: Discussion and possible action regarding a retroactive extension of deadlines to commence and complete construction on an affordable housing project to be built on 3.41 acres of undeveloped land with Assessor's Parcel Number 010-037-06 ("Phase 2 Property") through a development agreement ("Phase 2 Agreement") between Carson City and PalaSeek LLP, Oikos Development Corporation, and Sierra Flats Family I LP (collectively, "Developer") that was approved by the Board of Supervisors ("Board") on April 6, 2023. (Darren Schulz, DSchulz@Carson.org and Randall Rice, RRice@carson.org)

Staff Summary: Construction has commenced on the first phase of PalaSeek, LLP's ("PalaSeek") affordable housing project ("Phase 1 Project"), to be built on APN 010-037-07 ("Phase 1 Property"). Under the Phase 2 Agreement, Developer will construct an 80-unit affordable housing project ("Phase 2 Project") on the

Phase 2 Property. The Phase 2 Agreement provides that, unless the City consents in writing to an extension, the Phase 2 Agreement expires if Developer has not commenced construction of the Phase 2 Project by July 1, 2023. Developer and the City are still working together to get the plans for the Phase 2 Project approved; therefore, Developer was not able to commence construction before July 1, 2023, and seeks a retroactive extension of the deadline to commence construction of the Phase 2 Project.

13. Purchasing and Contracts

13.a. For Possible Action: Discussion and possible action regarding a second request for an increase in purchase authority in the amount of \$28,300, beyond the previously approved \$139,377, resulting in a new annual not to exceed amount of \$167,677, for the purchase of medications for persons detained in the Carson City Jail utilizing joinder Contract No. MMS2200730 between the Minnesota Multistate Contract Alliance for Pharmacy ("MMCAP") and Diamond Drugs, Inc. dba Diamond Pharmacy ("Diamond Pharmacy"), through June 30, 2023. (Carol Akers, cakers@carson.org and Nicki Aaker, naaker@carson.org)

Staff Summary: Pursuant to NRS 211.140, Carson City is responsible for providing prescription medication to persons who are detained in the Carson City Jail. The Carson City Department of Health and Human Services and Sheriff Ken Furlong are requesting the use of MMCAP Contract No. MMS17017 to purchase prescription medications from Diamond Pharmacy. This is a second request, for a retroactive increase, in the fiscal year because the orders were much higher than anticipated in January 2023, when the first increase request of \$69,377 was approved.

13.b. For Possible Action: Discussion and possible action regarding authorization to purchase medications for persons detained in the Carson City Jail, utilizing the Minnesota Multistate Contract Alliance for Pharmacy ("MMCAP") joinder contract with Diamond Drugs, Inc. for a not to exceed amount of \$170,400 through June 30, 2024. (Carol Akers, cakers@carson.org and Nicki Aaker, naaker@carson.org)

Staff Summary: Pursuant to NRS 211.140, Carson City is responsible for providing prescription medication to persons who are detained in the Carson City Jail. The Carson City Department of Health and Human Services and Sheriff Ken Furlong are requesting the use of MMCAP Contract No. MMS2200730 to purchase prescription medications from Diamond Drugs, Inc.

13.c. For Possible Action: Discussion and possible action regarding authorization to purchase vaccines utilizing the Minnesota Multistate Contract Alliance for Pharmacy ("MMCAP") joinder contract with GlaxoSmithKline ("GSK") for a not to exceed amount of \$81,000 through June 30, 2024. (Carol Akers,

cakers@carson.org and Nicki Aaker, naaker@carson.org)

Staff Summary: The Carson City Department of Health and Human Services utilizes MMCAP Contract No. MMS2000177 to purchase vaccinations and immunization supplies from GSK for vaccination through Clinical Services and Public Health Preparedness Community vaccination efforts. This will be funded from the Health and Human Services State Vaccine, Private Vaccine and Community Vaccine & Outreach revenue accounts through June 30, 2024.

13.d. For Possible Action: Discussion and possible action regarding authorization to purchase vaccines utilizing the Minnesota Multistate Contract Alliance for Pharmacy ("MMCAP") joinder contract with Sanofi Pasteur Inc. ("Sanofi") for a not to exceed amount of \$63,000 through June 30, 2024. (Carol Akers, cakers@carson.org and Nicki Aaker, naaker@carson.org)

Staff Summary: The Carson City Department of Health and Human Services utilizes MMCAP Contract No. MMS2000294 to purchase vaccinations and immunization supplies from Sanofi for vaccination through Clinical Services and Public Health Preparedness Community vaccination efforts. This will be funded from the Health and Human Services Private Vaccine and Community Vaccine & Outreach revenue accounts through June 30, 2024.

13.e. For Possible Action: Discussion and possible action regarding purchase authority under joinder contracts for a total amount not to exceed \$977,615 through January 31, 2024, to secure: (1) bulk fuel and related delivery services utilizing State of Nevada joinder contract 99SWC-NV20-4287 with Interstate Oil Company ("Interstate"), 99SWC-NV20-4867 with Carson Valley Oil Co., Inc. ("Carson Oil") and 99SWC-NV20-4283 with Flyers Energy, LLC ("Flyers"); and (2) additional fuel access through a card lock fueling network using State of Nevada joinder contract 99SWC-NV21-7551 with Pilot Thomas Logistics, LLC ("Pilot"). Staff Summary: Through these joinder contracts, the City purchases bulk fuel for City-owned vehicles and provides a card lock fueling network which allows City employees to refuel City vehicles when unable to refuel at a City refueling location.

13.f. For Possible Action: Discussion and possible action regarding authorization to purchase radio communications equipment, software and related services to support the capital and operational needs of Carson City's various offices and departments during Fiscal Year ("FY") 2024, for a total aggregate amount not to exceed \$1,200,000 through joinder contract P697-16-016 between Harris Corporation and the State of Nevada. (Carol Akers, cakers@carson.org and James Jacklett, jjacklett@carson.org)

Staff Summary: This purchase authority and joinder contract will allow the City to purchase radio equipment, software and related services necessary to support the public safety radio system needs of the City's various offices and departments during FY 2024.

13.g. For Possible Action: Discussion and possible action regarding authorization to purchase Sodium Hypochlorite ("Bleach") for use at the Carson City Water Resource Recovery Facility ("WRRF"), the Quill Water Treatment Plant ("Quill") and the Aquatic Center utilizing joinder contract 212528 between the City of Tucson ("Tucson") and Thatcher Company of Arizona, Inc. ("Thatcher") for a not to exceed amount of \$614,000 through June 30, 2024, and authorization for the Purchasing and Contracts Administrator to extend the joinder contract when it is renewed. (Carol Akers, cakers@carson.org and Andy Hummel, ahummel@carson.org)

Staff Summary: The Carson City Public Works and Parks, Recreation and Open Space Departments utilize Bleach to disinfect water at the WWRF, Quill and the Aquatic Center. The joinder contract will expire on September 30, 2023, but Tucson and Thatcher can renew for another year under the joinder contract's terms.

13.h. For Possible Action: Discussion and possible action regarding Contract 24300003 for Empire Southwest LLC ("Empire") to provide repair and preventative maintenance services as needed for heavy equipment at the Carson City Landfill ("Landfill") during Fiscal Year ("FY") 2024, for an annual amount not to exceed \$150,000. (Carol Akers, cakers@carson.org and Rick Cooley, rcooley@carson.org)

Staff Summary: The Landfill operates seven pieces of Caterpillar brand heavy equipment and five other brands of heavy equipment that require repair and maintenance throughout any given year. Empire is the only authorized service provider with access to Caterpillar's proprietary diagnostic equipment; therefore, Empire performs most of the repairs and maintenance on the Landfill's heavy equipment.

13.i. For Possible Action: Discussion and possible action regarding authorization for the purchase of Badger water meters and related parts through Ferguson Waterworks ("Ferguson") for a not to exceed amount of \$150,000 through Fiscal Year ("FY") 2024. (Carol Akers, cakers@carson.org and Andy Hummel, ahummel@carson.org)

Staff Summary: Carson City provides and maintains water meters for residents, the cost of which is offset by utility connection fees. The Water Utility Division ("Division") of the Carson City Public Works Department monitors most of its water meters with the Orion Automatic Meter Reading System ("Orion System"),

which is designed to be compatible with only Badger meters and parts. The Division expects to expend approximately \$150,000 on Badger meters and parts in FY 2024.

13.j. For Possible Action: Discussion and possible action regarding authorization to purchase Celatom FW12 diatomaceous earth filter media for municipal water treatment from EP Minerals, LLC ("EPM") for a not to exceed annual amount of \$90,000 through June 30, 2024. (Carol Akers, cakers@carson.org and Andy Hummel, ahummel@carson.org)

Staff Summary: The Water Division of the Carson City Public Works Department anticipates the use of approximately 160 tons of diatomaceous earth filter media annually to treat municipal water. EPM is the only known local supplier that can reliably provide the quantity and quality of diatomaceous earth needed for municipal water treatment.

13.k. For Possible Action: Discussion and possible action regarding Contract No. 23300340 ("Contract") for Lumos and Associates, Inc. ("Lumos") to provide design, engineering and construction management plans for Phase III of the Carson River Trail System, covering the Prison Hill West segment ("Project"), for a total not to exceed amount of \$442,120. (Carol Akers, CAkers@carson.org; Michael Friend, mfriend@carson.org; and Gregg Berggren, gberggren@carson.org).

Staff Summary: The Project deliverables include, but are not limited to, plans, specifications and bid documents for the Project's layout, design, engineering, permitting and construction management. The Southern Nevada Public Land Management Act ("SNPLMA") will fund the Contract's not to exceed amount of \$442,120 through a grant administered by the Bureau of Land Management ("BLM").

13.1. For Possible Action: Discussion and possible action regarding the proposed ratification of a contract with Flock Group, Inc. for the Flock Safety Falcon License Plate Reader ("LPR") Platform camera and software implementation and subscription for the Carson City Sheriff's Office ("CCSO"), for a total amount not to exceed \$148,500 for a one-year term commencing upon completion of implementation. (Carol Akers, cakers@carson.org and Sheriff Ken Furlong, kfurlong@carson.org)

Staff Summary: Flock Safety will supply the CCSO with cameras using LPR technology that will be installed throughout the community. This hardware and technology will be used in real-time to identify wanted vehicles, including vehicles subject to AMBER and Silver alerts, and to help protect against property crime, violent crime and more. This purchase was approved as part of the Fiscal Year ("FY") 2023 Capital Improvement Plan ("CIP").

15.a. For Discussion Only: Discussion and presentation of a biannual report on Carson City jail conditions and information concerning deaths of prisoners within the jail. (Earl A. Mays III, emays@carson.org)

Staff Summary: During the 2019 Legislative Session, the Nevada Legislature enacted Assembly Bill (AB) 301, which requires the Sheriff to submit to the Board of Supervisors ("Board") a biannual report containing aggregated data similar to the information required to be submitted pursuant to the federal Death in Custody Reporting Act of 2013, Public Law 113-242, concerning the deaths of prisoners in the jail during the immediately preceding 6 months and the circumstances surrounding any such deaths. AB 301 also requires the Board, at least twice each year, to include as an item on the agenda of a public meeting a consideration of the conditions of the jail, the number of deaths of prisoners in the jail and the known circumstances surrounding any such deaths during the immediately preceding 6 months.

15.b. For Possible Action: Discussion and possible action regarding the acceptance of a donation of 48 automated external defibrillators ("AEDs") from the State of Nevada, Department of Health and Human Services (the "State"), funded by the Leona M. and Harry B. Helmsley Charitable Trust ("Charitable Trust"), at no cost to the City. (Jerome Tushbant, jtushbant@carson.org)

Staff Summary: The Charitable Trust, in partnership with the State, is donating 48 AEDs to the Carson City Sheriff's Office ("CCSO"). This donation is intended to provide peace officers with life-saving technology necessary to respond quickly to medical emergencies and improve cardiac arrest survival before the arrival of Emergency Medical Services ("EMS").

16. City Manager

16.a. Staff Summary: Carson City and IAFF have engaged in extensive labor negotiations for a successor CBA, as the current CBA term expired on June 30, 2023. The proposed CBA is for a 5-year term, expiring June 30, 2028. This matter is being considered in accordance with the public hearing process set forth in NRS 288.153.

17. Finance

17.a. For Possible Action: Discussion and possible action regarding the Fiscal Year ("FY") 2024 Audit Work Program and audit services recommended by the Audit Committee to be performed by the City's retained internal auditor, Eide Bailly, LLP, for an amount not to exceed \$110,000. Staff Summary: Eide Bailly, LLP made recommendations for future projects at the Audit Committee's June 16, 2023, meeting based on their risk assessment procedures performed. The Audit Committee discussed those recommendations and, based on the budget available, selected various projects that are being recommended to be included in the FY 2024 Audit Work Program.

Staff Summary: The Board of Supervisors is required to annually establish the number of residential permits that will be available for the following calendar year pursuant to the Growth Management Ordinance. A total of 765 residential allocations are proposed to be made available for 2024 with 510 of the allocations made available for market rate housing units and 255 allocations made available for affordable housing units. The commercial and industrial daily water usage threshold is proposed to be modified from 15,000 gallons per day annual average to 10,000 gallons per day annual average, above which Growth Management Commission approval is required.

Staff Summary: The Redevelopment Authority annually funds arts and culture grants from a portion of the Revolving Fund. The Carson City Cultural Commission received a total of \$69,500 in grant requests, and a total of \$25,000 has been allocated in the FY 2024 budget for those activities.

The business impact statement finds that the Policy will not impose a direct and significant economic burden upon a business or directly restrict the formation, operation or expansion of a business.
