Staff Summary: Every month the Board of Supervisors presents Length of Service certificates to employees who have completed 5, 10, 15, 20, 25 and 30 years of City service.

## 8. City Manager

8.a. For Possible Action: Discussion and possible action on ratifying the approval of bills and other requests for payments by the City Manager for the period of June 3, 2023, through July 7, 2023. (Nancy Paulson, npaulson@carson.org)

Staff Summary: Pursuant to Carson City Municipal Code ("CCMC") Chapter 2.29, the Controller will present all bills or other requests for payment by the City to the City Manager for approval. Upon approval, the register book of bills and other requests for payment and warrants are presented at least once a month to the Board of Supervisors, who shall, by motion entered into its minutes, ratify the action taken.

8.b. For Possible Action: Discussion and possible action regarding the appointment of a representative member to the Nevada Local Justice Reinvestment Coordinating Council ("NLJRCC") pursuant to NRS 176.014 for a two-year term. (Nancy Paulson, npaulson@carson.org)

Staff Summary: The NLJRCC was created by the Nevada Legislature with the enactment of Assembly Bill ("AB") 236 during the 80th (2019) Legislative Session. Pursuant to section 7 of AB 236, subsequently codified as NRS 176.014, the Carson City Board of Supervisors ("Board") is required to appoint one member to the NLJRCC. Although the statute does not specify required qualifications for members to be appointed, the Sentencing Commission has indicated that the NLJRCC should be comprised of stakeholders from the criminal justice system and mental health and treatment communities. Chief Deputy District Attorney Garrit Pruyt is seeking reappointment.

#### 9. Finance

9.a. For Possible Action: Discussion and possible action regarding the report on the condition of each fund in the treasury and the statements of receipts and expenditures through July 7, 2023, per NRS 251.030 and NRS 354.290. (Sheri Russell-Benabou, srussell@carson.org)

Staff Summary: NRS 251.030 requires the Chief Financial Officer (for the purpose of the statute acting as the County Auditor) to report to the Board of Supervisors, at each regular meeting thereof, the condition of each fund in the treasury. NRS 354.290 requires the County Auditor to report to the Board of Supervisors a statement of revenues and expenditures based on the accounts and funds as were used in the budget. 10.a. For Possible Action: Discussion and possible action to authorize payment in the amount of \$259,749.73 to Central Square Technologies, LLC ("Central Square") to maintain the Carson City Sheriff's Office's ("CCSO") Public Safety Software system during Fiscal Year ("FY") 2024. (Carol Akers, cakers@carson.org, Frank Abella, fabella@carson.org and Jerome Tushbant, jtushbant@carson.org)

Staff Summary: The CCSO currently uses Central Square (formerly known as Tiburon and Tritech Software Systems) as the vendor for maintaining its Public Safety Software. This is an annual bill for software maintenance.

10.b. For Possible Action: Discussion and possible action regarding authority to purchase emergency medical equipment and supplies during Fiscal Year ("FY") 2024 utilizing joinder contract 2021002973 between Henry Schein, Inc. and the University of California for a not to exceed amount of \$80,000. (Carol Akers, CAkers@carson.org and Sean Slamon, SSlamon@carson.org)

Staff Summary: Through this joinder contract, the Carson City Fire Department will purchase emergency medical equipment and supplies used on a daily basis for emergency medical services responses. This includes items such as IV supplies, medications, bandages, splints and other items used in the treatment of patients at the scene of medical calls and during transport.

10.c. For Possible Action: Discussion and possible action regarding authorization to utilize joinder contract 3086-19 ("Joinder") between Washoe County and ARC Health and Wellness Centers ("ARC") to secure employee medical services during Fiscal Year ("FY") 2024 for a not to exceed amount of \$125,000, and to authorize the Purchasing and Contracts Administrator to execute any documents necessary for Carson City to utilize the Joinder during FY 2024. Staff Summary: ARC provides the annual heart and lung physicals for the Carson City Sheriff's Office, court bailiffs and marshals and the Carson City Fire Department. The physicals are required by NRS 617.454.

10.d. For Possible Action: Discussion and possible action regarding Contract No. 24300089 with DOWL, LLC ("DOWL") to provide design services for the Timberline and Lakeview Electrical Design Project ("Project"), for a not to exceed amount of \$70,110. (Carol Akers, cakers@carson.org and Randall Rice, RRice@carson.org)

Staff Summary: DOWL has been selected to provide design services for upgrading the electrical systems for the Timberline and Lakeview booster pump systems. The overall goal of this Project is to provide a more reliable and safer water distribution system in the Timberline and Lakeview areas. This Project was approved as part of the Fiscal Year ("FY") 2022 Capital Improvement Plan ("CIP").

10.e. For Possible Action: Discussion and possible action regarding Contract No. 24300006 with Michael Baker International, Inc. ("MBI") for on-call Geographic Information Systems ("GIS") services through Fiscal Year ("FY") 2024, for an amount not to exceed \$125,000. (Carol Akers; CAkers@carson.org and Randall Rice; RRice@carson.org)

Staff Summary: MBI provides on-call GIS support to Carson City for internal services, external (public) services and optimizing and upgrading workflows to save time and money. Staff recommends continuing the City's engagement with MBI to leverage the specialized technical skillsets MBI possesses to perform the contracted work.

10.f. For Possible Action: Discussion and possible action regarding Contract No. 24300007 with Atkins North America, Inc. ("Atkins") for on-call Geographic Information System ("GIS") services through Fiscal Year ("FY") 2024, for a not to exceed amount of \$95,000. (Carol Akers, CAkers@carson.org and Randall Rice, RRice@carson.org)

Staff Summary: Atkins provides on-call GIS support to Carson City for the deployment of ESRI's Enterprise GIS platform, deployment of web applications, mobile data collection tools, dashboard development, database management and system administration. In addition, Atkins supported the successful completion of the first phase of the CITYView application as well as finalizing the GIS Enterprise architecture update. Staff recommends continuing to engage Atkins to

leverage the specialized technical skillsets Atkins possesses to perform the contracted work.

10.g. For Possible Action: Discussion and possible action regarding Contract No. 24300008 with Carson Pump, LLC ("Carson Pump") for water well maintenance and on-call services, for a not to exceed amount of \$250,000 through June 30, 2024. (Carol Akers, cakers@carson.org and Andy Hummel, ahummel@carson.org)

Staff Summary: Annually, the Carson City Public Works Department ("Public Works") contracts with Carson Pump for water well maintenance and on-call services, which can include the purchase of pumps and related parts and well rehabilitation and repair services.

10.h. For Possible Action: Discussion and possible action regarding Contract No. 23300326 with Sierra Nevada Construction, Inc. ("SNC") for the Eagle Station Sewer Replacement Project ("Project") for a total amount not to exceed \$2,246,482.70, to be awarded without competitive bidding under NRS 338.1385(7). (Carol Akers, CAkers@carson.org and Randall Rice, RRice@carson.org)

Staff Summary: This Project includes replacing sewer main in the area of Eagle Station Lane and replacing a water pressure relief valve with a water check valve near the intersection of Silver Sage Drive and Koontz Lane. The contract is being awarded without competitive bidding under NRS 338.1385(7) because no contractors responded to the Project's original solicitation or a second notice that the contract would be awarded without competitive bidding if no bids were submitted. The not to exceed amount of \$2,246,482.70 comprises a base bid amount of \$2,042,257.00, plus a 10% contingency of \$204,225.70. The engineer's estimate was \$1,900,000. This Project was approved as part of the Fiscal Year ("FY") 2022 Capital Improvement Plan ("CIP").

Staff Summary: Carson City and CCSSA have engaged in extensive labor negotiations for a successor CBA, as the current CBA term expired on June 30, 2023. The proposed CBA is for a five-year term, expiring June 30, 2028. This matter is being considered in accordance with the public hearing process set forth in NRS 288.153.

12.b. For Possible Action: Discussion and possible action on a proposed collective bargaining agreement ("CBA") between Carson City and the Carson City Fire Fighters Association, Local # 2251 of the International Association of Fire Fighters ("IAFF") on behalf of Carson City Fire Department employees with the rank of Battalion Chief, to be retroactively effective beginning July 1, 2023, and expiring June 30, 2027, with an estimated fiscal impact of \$661,708 above the five-year projections included in the Fiscal Year ("FY") 2024 City budget which was previously approved by the Board of Supervisors ("Board"). Staff Summary: Carson City and IAFF have engaged in extensive labor negotiations for a successor CBA, as the current CBA term expired on June 30, 2023. The proposed CBA is for a four-year term, expiring June 30, 2027. This matter is being considered in accordance with the public hearing process set forth in NRS 288.153.

12.c. For Possible Action: Discussion and possible action regarding the appointment of one member to the Carson City Culture and Tourism Authority ("CTA"), as a representative for other commercial interests in Carson City, for a two-year term expiring on July 19, 2025. Staff Summary: In 2007 and 2010, Carson City acquired the Property without water rights due to limited funding available at the time of acquisition. Since 2019, staff have worked to identify strategies for the City to acquire water rights to ensure the Property's agricultural heritage and natural resource values can be preserved for future generations. This item would enable staff to initiate the due diligence process for potential acquisition of water rights for the Property.
