Staff Summary: The Board of Supervisors ("Board") approved the tentative subdivision map SUB-2020-0016 on February 18, 2021. Borda Crossing, LLC ("Applicant") has requested an extension of time stating that with the current interest rates and construction costs buyers would not be able to qualify to purchase the homes. The applicant is seeking a one-year extension of time consistent with NRS 278.350(1) (a) in hopes that the market will stabilize and normalize within the home lending environment.

#### 10. Juvenile

10.a For Possible Action: Discussion and possible action regarding (1) the proposed acceptance of the Comprehensive Opioid, Stimulant, and Substance Use Program ("COSSUP") sub grant funds from the Nevada Attorney General's ("AG's") Office in the amount of \$132,694, effective August 15, 2023 through September 30, 2024, to be used for the COSSUP sub grant funded full time employee ("FTE") for the Juvenile Outreach Specialist position, a contracted Drug and Alcohol Counselor and operational supplies, and (2) authorization to accept an additional sub grant of COSSUP funds from the AG's Office for Fiscal Year ("FY") 2025, if awarded, for a not to exceed amount of \$150,000, to be used for the same purposes. Staff Summary: The Department of Juvenile Services of the First Judicial District Court ("Juvenile Services") received the Comprehensive Opioid, Stimulant, and Substance Abuse Program ("COSSAP") grant funds for FY 2023 as a sub grant through Partnership Carson City ("PCC") for \$90,000 for the Juvenile Outreach Specialist position. The COSSAP grant is now the COSSUP grant, and is now funded directly through the AG's Office. The AG's Office is awarding Juvenile Services additional funds to allow Juvenile Services to contract with a Drug and Alcohol Counselor for needed services and to obtain operational supplies.

Staff Summary: As part of Carson City's Saliman and Mills Park Drainage Improvements Project ("Project"), the City plans to construct storm drain improvements along portions of the northern and eastern property lines of Mills Park that will ultimately connect to an existing storm drain channel on property owned by the Carson City School District ("CCSD"). The Easement is necessary to connect the planned Project improvements at Mills Park to the storm drain channel on CCSD property. Acorn Hills has agreed to grant the Easement to the City at no cost. Staff Summary: CCHHS desires to minimize its direct involvement with public health billing while maintaining the highest level of customer service and maximizing collections and timely and accurate reporting. If the option to extend the term of the Contract is approved, the Contract will continue to be funded by the Clinical Services, State Vaccine, Private Vaccine and Community Vaccine Outreach accounts.

Staff Summary: In November of 2020, Carson City used federal Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") funding for the emergency purchase of hardware and software to improve cybersecurity and data backup capabilities. 12.c For Possible Action: Discussion and possible action regarding a determination that Reyman Brothers Construction, Inc. ("Reyman Brothers") is the lowest responsive and responsible bidder pursuant to Nevada Revised Statutes ("NRS") Chapter 338 and whether to award Contract No. 24300265 for the Fleet Tire and Welding Shop Project ("Project") to Reyman Brothers for a total amount not to exceed \$1,360,256.70. Staff Summary: At the Public Works Corporate Yard, Fleet Services currently operates a maintenance building and a small separate tire shop building. The Project will consist of demolishing the existing tire shop building and constructing an addition to the maintenance building that will house a new tire and welding shop. The not to exceed amount of \$1,360,256.70 comprises the base bid amount of \$1,202,865, the Alternate Bid Item 1 amount of \$33,732 and a 10% contingency of \$123,659.70.
