Summary: Currently the 9-1-1 Surcharge fund pays the monthly fee for AT&T's E9-1-1 services for the Carson City Public Safety Dispatch Center under a contract approved by the Board in January 2017. The requested funding represents an increased, reoccurring monthly service fee of \$15,981.17, in addition to a one-time fee of \$3,282.67 for infrastructure updates and replacements.

Public comment will be limited to three minutes per speaker to facilitate the efficient conduct of a meeting and to provide reasonable opportunity for comment from all members of the public who wish to speak. Testimony from a person who is directly involved with an item, such as City staff, an applicant or a party to an administrative hearing or appeal, is not considered public comment and is not subject to the three-minute time limitation.
