Staff Summary: This Contract with EagleView is for aerial photography of Carson City. The Contract is broken-down into three separate flight projects. The first flight and photography project will take place in 2025, the second in 2027 and the final flight will be in 2029. The initial payment of \$28,595.97 for each project is due upon provision of the imagery in the year of the flight and the second payment of \$28,595.97 is due one year later for continued access to the images and software maintenance. The two-year combined cost for each flight project is \$57,191.94.
